MINUTES September 24, 2020 Via Zoom

CALL TO ORDER - FLAG SALUTE

President Tom Sutich called the meeting to order at 7:00 p.m. no flag salute was held due to meeting virtually. He requested everyone mute their microphone so there's not a lot of background sound.

WELCOME and THANK YOU TO HOST

President Sutich thanked everyone for attending tonight's meeting.

ROLL CALL – SELF-INTRODUCTIONS

There were 23 people in attendance.

PROGRAM – Mike Lonergan – PC Assessor Treasurer

Vice President Moffett introduced PC Assessor Treasurer Mike Lonergan. Mike stated on behalf of the taxpayers appreciate all of the Fire Departments and their work with all of the recent wildfires. Looking at properties and valuing for property taxes. Figures are also used for FEMA reports as well. Levy Specialist Kim Fleshman is on vacation. Preliminary packets were mailed on Monday to all the Districts. Utilities are done by Department of Revenue and we don't have those yet. New construction, new valuation cards to go out in a few days. June, July, August out inspecting those with building permits. Still added county-wide 2 billion 234 million dollars to tax rolls. Thought would be down this year but was 13 million higher than last year. Ran through breakdown of new construction for each district. MSRC has great resources. Information in packets. Revalue entire county end of June this year, PC is now worth 136.4 billion dollars. Residential properties still healthy increase over last year 8.8% increase. Still a seller's market. Discovered they had been undervaluing mobile homes for some time. 24.5% value increase in mobile homes. Some of those people are appealing. Rightly so. Market is still strong, new homes being built. Residential should continue steady for a while. Some things on horizon - PC Planning – furnish estimated tax revenue from proposed housing developments. Since a fire district has asked for impact fees, etc. Do best to give an approximate amount on what value would be based on current rates, etc. 1 other fire district may be looking at Fire Benefit Charge like Central Pierce. \$1.50 max drops to \$1.00 but then also receive the FBC that is charged against exempt properties as well as taxed properties. Offices still closed by order of the Governor. Have 20 staff of 75 people reporting to PC Annex, a few come in once a week. Quite productions with 55 of 75 working from home. Waiting to see when Governor says more employees to return and to open doors to the public. October 31st due date still stands. April 30th due date extended to June. Not extending October 31st payment except it falls on a Saturday so extends due date to Monday, November 2nd.

President Sutich asked if there is any discussion or opposition. Hearing none the August 27, 2020 minutes as presented were passed unanimously.

REGULAR REPORTS:

a) Regional Representative Report - Mike Cathey

Not present. Commissioner Rankin reported met September 12th. WFCA Board of Directors meet on 21st done by Zoom or in person in Olympia as they are in Phase 3. Classes are out via web-ex. 4 classes to sign up for as well as Snure's class. Healthcare committee met and passed on to the 21st meeting. Getting ready to switch to the new website. Making things easier to find and more friendly to operate.

b) Legal - Joe and/or Eric Quinn

Joe Quinn reported the webinar mentioned in October to replace part of WFCA conference, 4 or 5 attorneys including Eric Quinn on various responses to pandemic situation we find ourselves in such as responding to FEMA and reimbursements, etc. Emergency declarations and various pandemic related issues such as FMLA and other personnel matters. How do you pay employees if quarantined, etc. Have some interesting issues – Dept of Labor investigation of all volunteer district on whether or not volunteer employees and should be paid overtime or are bona fide volunteers, etc.

c) SouthSound 911 – Debbie Grady

Reported couple things interested in – study session on October 21st for SS911 Board for two radio systems in the County to talk about user rates, interoperability. Web-ex invitation has gone out, let know if not received. After first of year another study session from county E911 office to talk about E911 tax dollars in County. Deputy Director Duggan stated updated CAD upgrade – first major upgrade since installed in 2015. Mobile responder app will be able to be used by field responder. November 10th is when upgrade is scheduled.

Commissioner Holm asked Director Grady for a summary on subsidy changes coming. Director Grady reported at Board meeting a month ago voted unanimously to discontinue a subsidy to CCN and City of Tacoma to offset user rates for radios in county. Resulted in both radio providers then had to determine change in rates to their fees, etc. Last meeting CCN user fees approximately \$75.00 per radio and City of Tacoma users charged around \$39.00 per radio per user per month. October 21st follow up for both to share joint presentation and discussion with SS911 Board of impact and ongoing costs. Commissioner Egan asked about the new building. On track, on budget and on time for potential April/May move in. A lot of work groups in place to make transition as smooth as possible.

STANDING COMMITTEES:

a) Fire Chiefs Association - Dan Rankin / Tom Sutich

Reported they met via Zoom on September 3rd. Presentation was supposed to be the American Red Cross but they had been deployed. Chief Sharp gave an update on South Sound 911. Their next meeting will be held via Zoom on October 1st at 0900.

b) Legislative - Dale Mitchell

Reported met yesterday and will meet again next month. Ryan presented raising taxes next session. 8-9 million short fall. Not sure what going to do. Going to make sure they don't do anything to impact fire levies. Volunteer pension monies and LEOFF pension funds could be hit by this. 086 funds for training. Income tax is being looked at as well. COVID19 monies looking at as well. FMLA looked at last year, not going to do a lot with that as too many other issues that are more concerning. Look at recruiting and retaining firefighters – special effort on and working with the Chiefs. Educate new legislators. Legislative package will be out mid to end of November. Any ideas, thoughts, etc. let him or Roger Ferris know. Attorney Joe Quinn stated not going to pursue paid FMLA law. Legal opinion to their clients has been: Attempt to make elected officials pay into paid FMLA account is unlawful. use definition in fair labor standards act – Federal law. Excludes elected officials and volunteers. Interpretation of employment security department. It's new to them. See no reason to pay it. Discussion followed.

c) Bates Technical College - Dan Rankin

Reported all classes being done virtually on line.
