

# PIERCE COUNTY FIRE COMMISSIONERS' ASSOCIATION

MINUTES May 26, 2022 Remotely via Zoom

#### **CALL TO ORDER - FLAG SALUTE**

President Stan Moffett called the meeting to order at 7:00 p.m. no flag salute was held due to meeting virtually.

#### **WELCOME and THANK YOU TO HOST**

President Moffett thanked everyone for attending tonight's meeting.

No roll call or self-introductions were done. There were 21 people in attendance.

Nick Swinhart Key Peninsula new Fire Chief from Aberdeen. Thanked for the introduction and welcome.

### **GUEST SPEAKER – Mike Lonergan, PC Assessor Treasurer**

President Moffett introduced PC Assessor Treasurer Mike Lonergan. Explained Orting Valley switched to Fire Benefit Charge this year. Not assessed value based. Joined CPFR who has done for several years and Graham who started last year. They messed up when heard that OVFR hadn't received any money yet. Software had put the money in CPFR's account instead of OVFR's. That has been corrected and straightened out. Interesting time with wrapping up physical inspection and appraisal – year #3 of 6-year cycle. 1/6 of commercial properties looked at each year. Hot off the press, not certified yet, 2021 figures used for this year's taxes totals 159 billion dollars. More than doubled in 9 years. Looking to start on new construction now. Things are still going up. Nationwide figure median home in US is \$375,000 as of March this year. Increase of 15% from March of last year. Went over some rough numbers for Districts percentage increases. Apartments are included in commercial. 101% rule and value of new construction. Question asked about finding demographic information for a District? Mike Lonergan stated the GIS department of the County as some information. Requested an email be sent to him and he'll see what he can find out.

The Association thanked PC Assessor Treasurer Mike Lonergan for his presentation and information he shared this evening. We'll be sending a challenge coin as a thank you.

# c) SouthSound 911 - Debbie Grady

Thanked the association for the letter sent to the Board of Directors recognizing her attendance at these meetings. She appreciated that. Yesterday Board met and approved 4 agreements related to transition of 911 program office to SS911. Excited about that. In 2023 transitions the 911 excise tax fully to SS911. It's been a long process and long time in coming. Without your support don't think we'd be where we're at. June 8th retreat – 1/10 of 1% sales tax funding stream, future of radio systems in PC and what best practices are, etc. 1/10 of 1% by end of 2023 will be paid off and perfect timing to talk about funding and what can do to support field users, etc. Motion to approve the Board to reimburse agencies in CODE Red – failed with a split vote. Asked to be put on retreat agenda. Open House in June will be giving tours.
