Joe reported reminder of municipal roundtable tomorrow morning at noon via zoom regarding Diversity, Equity and Inclusion. Will put the link in the chat box. It was also emailed out earlier today as well as being in the Firehouse Lawyer.

Senate Bill 1735 designed to remedy some of the issues from previous law enforcement laws. A change made is that Police have right to use reasonable force to detain for involuntary commitment.

Case out of supreme court wrote about in firehouse lawyer newsletter. Houston Community College vs Wilson. 9 member board sued college board, private investigator hired, \$270,000 in legal fees, censuring him for his conduct. He lost 9 to nothing. Court ruled unanimously that Board has power to pass resolution to censor. Another case New York state law struck down open carry. Might embolden others to carry guns, etc. Too soon to say.

c) SouthSound 911 – Debbie Grady

Scott Hamel is here in place of Debbie Grady. A lot going on recently, Joint Board retreat occurred. A lot of talk about radio systems, goal of moving to single radio system. Replacement strategies for subscriber radios. Code Red was also discussed and reimbursement requests – carried over to be talked about at Board meeting that occurred yesterday. Public Safety Operations Committee meeting also held. Radio System discussed again. Seems to be interest in working collaboratively. Positive movement. Approval for reimbursement to City of Puyallup for radio infrastructure improvements made. 2nd retreat scheduled for the fall.
