CALL TO ORDER - FLAG SALUTE

President Stan Moffett called the meeting to order at 7:00 p.m.

WELCOME and THANK YOU TO HOST

President Moffett thanked everyone for attending tonight's meeting. Believes this is the first meeting we've had in person in 3 years.

REGULAR REPORTS:

a) Regional Representative Report - Jerry Bickett

Reported WFCA has upcoming classes you can check them out online. Upset Commissioners on Thurston County side regarding WFCA not stepping up on certain issues. Something we should be doing.

b) Legal - Joe and/or Eric Quinn

Eric reported legislative issues not discussed. Couple of senate bills related to increasing LID from 1% to 3%. Only becomes law if another bill 5465 pertaining to potential wealth transfer law comes into effect. It would affect the first 250,000 of assessed value of residential homes. Been in many discussions about this. Proceed as though 1% LID sticking around. Don't see the \$250,000 tax credit bill passing in which case the 3% LID wouldn't go into effect. Any questions can send copies of applicable bills.

Non legislative news a lot of supply chain issues with regards to purchasing staff vehicles. Clients have declared market conditions. Can't claim that simply because not on state bid any longer. Needs to be a market wide impact on a particular supply change to declare that. Check your resolutions to ensure they are detailed enough.

King County FD question regarding action the Board took being invalid since a second of the motion wasn't taken. Still a valid action, however, always best to have a second of the motion.

McElligott asked Faust if any further information on either of the legislation bills that Eric mentioned. Brandon stated he is working on getting more information. Legislative Day frustration with a specific legislator and Roger and lack of transparency. Not told what or when hearings are, etc. He will be following up with Roger. Discussion followed. Brandon to follow up and have an update at next month's meeting.

c) SouthSound 911 - Deborah Grady

Not present. Scott Hamel went over housekeeping issues. Communications Center is further in the building and more secure. Board of Directors meeting this week included Chair and Vice Chair elections. Chair Julie Door and Vice Chair McElligott. Congratulated Pat. Working on issues of radio systems in PC and work towards achieving a single system. Waiting for information from vendor, Motorola. Role of 911 Program Office transitioned from DEM to SS911. Excise Tax all comes to SS911 and manages program for Pierce County. Program Manager is being hired. Exceed 50,000 911 calls every month. Last year cleared 1 million incoming calls for the first time. Recently completed a recruiting video professionally done with a virtual tour. Available on their website. 35th Street facility being remodeled and updated. Goes out to bid in May and anticipate it being done by the end of the year. Dispatch Center known as PSAP (Public Safety Answering Point). Program for alarm notifications to be delivered electronically. Saves time and increased accuracy. Implemented in December. Technology improvements - initial phases spear headed by Chiefs Morrow and Doan for a connection with Kitsap County. Kitsap 911 has same CAD platform - Hexagon. Visibility into each other's system. Proactive on sharing resources for Gig Harbor, Key Peninsula and Kitsap, etc. Volunteers of America providing staff for 988 system – in process of hiring 3 employees for that. Anticipate working 7 days a week on swing shift.

STANDING COMMITTEES:

a) Legislative - Brandon Faust

Asked if anyone had any follow-up or input on how Legislative Day went. Commissioner Kadow commented there were 5 that went in to see JT Wilcox and was receptive. Also had a letter with talking points and he was appreciative of that. Positive reports from others. Great strategy to have a written document with talking points. Next legislative meeting will see where the dust settles on what made it through and what didn't, etc. Commissioner Homan stated the conference was good and a lot of good feedback. Several departments met jointly with legislators and able to have a little longer meeting with them. Suggestion might be meeting the day before and have a really good briefing on what the major issues are could go in better prepared to deliver a single message.

b) Bates Technical College - Dan Rankin

Reported met this morning. Couple things happening – in process of building new fire service facility on the grounds they have. 3 different buildings with props, station and a couple of other things. Having problems with getting Recruit Academies going. Issues with people backing out. Have to have 12 people to do a class. 23 students for EMT class currently. Next meeting is June 1st.
