MINUTES August 24, 2023
In Person at SS911 and Remotely via Zoom

CALL TO ORDER

President Moffett called the meeting to order at 7:00 p.m.

WELCOME and THANK YOU TO HOST

President Moffett thanked everyone for attending the picnic last month. It was a great turnout. Also we have a good turnout for tonight's meeting.

ROLL CALL – SELF-INTRODUCTIONS

There were 10 people in attendance according to the sign in sheet and 12 people on Zoom for a grand total of 22 people in attendance.

GUEST SPEAKER:

East Pierce Fire & Rescue FFPM Jen Killion on Mobile Integrated Health - President Moffett introduced Jen Killion who was attending via Zoom. She shared her screen and went through a powerpoint presentation on EPFR's Mobile Integrated Health/Community Paramedic Program. Developed the program in 2018. Brought on a behavior health specialist to help address mental health issues. Melissa Haney joined the program in April 2022. Both are on Peer Support Team. Last year we had 231 referrals. So far, this year have received 168 referrals. Meet and work with WPFR and CPFR CARES Managers. Jerry Bickett asked about Narcan being held on all Engines. Crews can administer, in PC Protocol. These are kits that are left at home for family to administer at a later time. A vending machine in Orting that people can get these kits. Commissioner Kadow asked if there are organizations or grants available for getting the Narcan kits? Get a grant through the Department of Health. Commissioner Wernet thanked very much for her presentation. Do FFs and EMTs that refer get feedback on referrals they make? And long-term cases mentioned. Jen stated that crews thank them as they see the reduction in response to high utilizers. Would be nice to have a better system to close the loop and get feedback from crews. 

 - Reduce low acuity 911 calls
 - Improve quality of life for vulnerable citizens through care coordination
- Work collaboratively with Assisted Living facilities in our district to reduce/improve 911 utilization, especially around Falls Prevention.
- Opioid Outreach
 - · Leave-home Naloxone kits on engines.
 - Automated referrals from EHR Software


Program Overview

- Represent EPFR in developing partnerships with law enforcement and social services organizations, as well as informing best practices in the region.
 - 2021 Collaboration regarding mental/behavioral health 911 calls
 - Law enforcement, Sound South 911, Mental Health Resources

 - Ongoing quarterly meetings to maintain communication channels and case review


2022

2022 BHS Impact


- True whole-person care

- Strong Peer Support presence




